Through this grant, Chamberlain University encourages eligible Historically Black Colleges and Universities (HBCU) employees to enroll in Chamberlain University's Doctor of Nursing Practice (DNP) degree program.

MSN Curriculum Advantage Grant (Up to \$5,160 in tuition savings) - MSN

The MSN Curriculum Advantage Grant was created to help eligible readmit students cover the cost of the additional required coursework due to the changes in the MSN curriculum.

New Student California Tuition Savings Offering (17-25% in tuition savings) - RN-BSN & RN-BSN to MSN

Chamberlain University is offering tuition savings for eligible California nurses interested in our RN-BSN Degree Completion option.

<u>New Student Tuition Savings Offering</u> (17-25% in tuition savings) - RN-BSN & RN-BSN to MSN Chamberlain University is offering tuition savings for eligible applicants interested in our RN-BSN Degree Completion option.

NR 565 Support Grant (Up to 100% of tuition and course fees) - MSN

Next Step Grant (Up to \$3,600 in savings) - MSN

The Next Step Grant is for new or readmitted students looking to fulfill a Nurse Executive role by completing a degree or certificate in Chamberlain's MSN Executive Track.

NP Alumni Grant (Up to 50% of tuition savings) - MSN

The NP Alumni Grant is for NP Certificate students who need to make up coursework due to sitting out of classes for over five years.

Nursing Excellence Grant (Up to \$3,840 in fee savings) - DNP

The Become Extraordinary Grant is a Chamberlain University grant offered to encourage students to further their education in select programs.

Public Health Community Grant (Up to \$6,342 in tuition savings) - MPH

The Public Health Community Grant is for students pursuing a career in a public health-related field.

Social Impact Grant (Up to \$8,340 in tuition savings) - MSW

The Social Impact Grant is for students pursuing a career in a social work-related field.



CONNECTED BY COMMUNITY GRANT

The Connected By Community Grant has been created to support newly enrolled BSN students who are residents of the State of California to begin their education at an alternative campus outside California.

Grant Amount: \$1,000 per session (up to \$5,000).

Initial Eligibility

- Acceptance into a Chamberlain University pre-licensure program and begin enrollment of at least five credits in each of the first five consecutive sessions enrolled.
- Students must have a California address on the Pre-Licensure BSN Application and attend an alternative campus outside of California.
- This grant is for campus-based students only.
- BSN Online is ineligible to receive this offering.
- Readmit students are eligible for the award.
- Continuing and non-matriculating students are not eligible for this award.
- Carryover students are eligible for the award.
- This offering is stackable with most other internal grants and scholarships except the Relocation Grant.

Continuing Eligibility

- Maintain good academic standing.
- Must enroll in five credits per session to qualify for full grant funding.

EXCELLENCE IN EDUCATION SCHOLARSHIP

Chamberlain University understands that securing financial assistance is an important component for students to begin their educational journey. The Excellence in Education Scholarship has been created to support new BSN students with exceptional academic scores in select Chamberlain campus locations.

Scholarship Amount: \$500 per session (up to \$5000).

Initial Eligibility

- Eligible applicants must apply and be accepted into the BSN Degree program at an approved Chamberlain University Campus.
- Campus locations in North Brunswick, Irwindale, and Sacramento are ineligible.
- BSN Online students are ineligible.
- The student must be a new student in May 2024. Continuing/Readmit students are ineligible.
- Must have an average HESI A2 custom score of 75 or greater
- Proof of graduation with a minimum of a 2.85 GPA on a 4.0 scale from a Chamberlain recognized High School or an institution recognized by the Council for Higher Education (CHEA).
- Students must enroll in at least 5 credit hours per session, starting with the May 2024 session, for 10 consecutive sessions to receive full scholarship funding.
- Non-matriculating students are not eligible for this Scholarship.
- This offering is nonstackable with most other internal grants and scholarships.

Continuing Eligibility

- Meet the eligibility requirement of 5 credits per session for 10 consecutive sessions.
- Maintain a cumulative GPA of 2.5 or greater
- Remain in good academic standing for the full term of the offering.

FUTURE OF NURSING GRANT

The Future of Nursing Grant is for pre-licensure applicants who previously applied but could not start their Academic Journey before the May 2024 session. Eligible campuses include: Tinley Park, Chicago, Troy, Addison, Columbus, St. Louis, Atlanta, Stockbridge, Charlotte, Tysons, Corner, Irving, Houston, Pearland, Jacksonville, Miramar, Phoenix, and BSN Online.

Grant Amount: \$250 per session (up to \$2,000).

Initial Eligibility

- Acceptance into a Chamberlain University pre-licensure program for the May 2024 session.
- Must be a student with a current intended start date of January 2024 or earlier but could not start.
- Continuing and non-matriculating students are not eligible for this award.

Continuing Eligibility

- Maintain a minimum enrollment of three credit hours per eligible session.
- Students who drop below the minimum enrollment requirement will be ineligible for payment for that session.
- Must complete the eligible eight sessions within 18 months of start date.

Grant Application Requirements



HEART OF HEALTHCARE PROGRAM (CHAMBERLAIN UNIVERSITY PORTION)

The Heart of Healthcare Program is for pre-licensure applicants ready to begin their education by starting Chamberlain's BSN degree program and chose to enter a 2.5-year work commitment at Ochsner Healthcare

Grant Amount: \$6,250 per traditional year for 3 years or until graduation (up to \$18,750).

Initial Eligibility

- Acceptance into Chamberlain's pre-licensure degree program starting the January 2023 session or after at the New Orleans campus.
- Must enroll in a full-time course load.
- Non-matriculating and continuing students are ineligible.
- Selected to participate in the Heart of Healthcare Program by Ochsner.

Continuing Eligibility

- Maintain good academic standing.
- Maintain full-time enrollment.
- Students acknowledge and agree that Chamberlain will only grant this financial offering when they have an account balance less than \$1,500 by the beginning of the academic session.

Grant Application Requirements

• Chamberlain will review admission application materials and selected students must complete an interview with Ochsner Healthcare to be considered for the offering.



NAVIGATE TO NURSING (N2N) SCHOLARSHIP PROGRAM

The Navigate to Nursing Program is a merit-based scholarship that provides financial assistance to allow qualified high school seniors to begin earning college credits toward their Bachelor of Science in Nursing (BSN) degree while still in high school. All credits are completed under the predetermined N2N Scholarship Program curriculum.

Grant Amount: 100% of tuition and student services charges for N2N curriculum courses.

Initial Eligibility

- Seniors from high schools recognized by Chamberlain University.
- Minimum high school CGPA of 3.2 on a 4.0 scale.

Continuing Eligibility

- Minimum CGPA of 2.0 on a 4.0 scale.
- Minimum enrollment of two credit hours per semester.
- Scholarship Application Requirements:
 - Official high school transcripts.
 - Parental consent form for applicants under the age of 18.
 - Review and approval by the Chamberlain Admissions Committee.

IMPORTANT NOTE: All grants and scholarships are limited based on availability of funding. Chamberlain University reserves the right to change offerings at any time. These are one-time awards that students may receive once within their life cycle.





NEW JERSEY NURSING PATHWAYS GRANT

The New Jersey Nursing Pathways Grant has been created to support newly enrolled BSN students who are residents of the State of New Jersey to begin their education at an alternative campus outside of New Jersey.

Grant Amount: \$1,000 per session (up to \$10,000).

Initial Eligibility

- The student must enroll in the Chamberlain University Campus-based BSN Degree Program.
- Eligible applicants must apply and be accepted at an approved Chamberlain University Campus at an eligible alternative Chamberlain Campus to North Brunswick, New Jersey.
- Campus locations in Troy, Las Vegas, San Antonio, Irwindale, Sacramento, and Indianapolis are ineligible for consideration when choosing an alternative location.
- BSN Online students are ineligible.
- The student must be a new or readmit student in May 2024. Continuing and non-matriculating students are ineligible.
- The student must enroll in a minimum of 3 credit hours in the May 2024 session and at least 5 credits per session for the remaining 9 sessions of eligibility.
- This offering is nonstackable with most other internal grants and scholarships.

Continuing Eligibility

- Must remain at a new campus outside of North Brunswick, New Jersey. Transferring to North Brunswick or any other campus would end grant funding.
- Must enroll in a minimum of 3 credits in the student's first session enrolled and 5 credits per session for the 9 consecutive sessions that follow. Ten consecutive sessions of enrollment will be required to receive full funding.
- Must remain in good academic standing. Failure to achieve this status will result in loss of eligibility for the grant.
- Students must have taken a course physically on the alternative campus by their third session enrolled, in September 2024.

ADVANCE CARE TOGETHER (ACT) GRANT

The ACT Grant offers tuition savings in addition to employer-sponsored tuition reimbursement over the course of one year.

Grant Amount: Up to 100% of tuition costs for the remainder of the student's 12-month healthcare partner's tuition benefit policy period after the student pays \$5,250 toward tuition.

Initial Eligibility

- New or readmitted students accepted into the RN to BSN option or RN-BSN to MSN options (*undergraduate portion only*).
 - ACT Grant recipients are ineligible for ACT grant funding when they enter graduate studies.
- Must be employed with a participating healthcare partner in the ACT Grant program.

Continuing Eligibility

- If students receive more than two allowances in the same 12-month cycle, then they become ineligible until the next 12-month tuition benefit cycle begins.
 - Allowances include course/session withdrawal and course grades of D or F.
 - Students may remain eligible to continue course progression without the grant.

Grant Application Requirements

- Completion of the Healthcare/Education Partnership Eligibility form.
- Signed ACT Grant Terms and Conditions Eligibility Requirements form.

Selection Requirements

• Eligible applicants accepted into an eligible Chamberlain University degree program will be automatically awarded when they have paid \$5,250 to their tuition costs.





ANNUAL ADVANCING CARE GRANT (AAC)

The AAC Grant offers tuition and non-book fee savings in addition to any employer-sponsored direct billing over the course of one year.

Grant Amount: Up to 100% of tuition and non-book fee costs for the remainder of the student's 12-month period after the student's employer is billed and directly pays Chamberlain \$6,000.

Initial Eligibility

- Must be a new or readmitted student.
- Must be enrolled in the RN-BSN Program (RN-MSN and RN-BSN to MSN are ineligible).
- Applicants must be employed with an employer participating in the AAC Program.

Continuing Eligibility

- Must maintain continued employment with a participating employer.
- Maintain good academic standing.

Grant Application Requirements

• Signed AAC Grant Terms and Conditions form.



BECOME EXTRAORDINARY GRANT

The Become Extraordinary Grant is a Chamberlain University grant offered to encourage students to further their education in select programs.

Grant Amount: 10% tuition savings.

Initial Eligibility

- Acceptance into Chamberlain's Accelerated MSN, Accelerated RN to MSN Option, Doctor of Nursing Practice (DNP) degree program, MSN Specialty Track (excluding Executive and Executive Certificates) or an MSN non-clinical certification program.
- Applicants must not qualify for any other Chamberlain grants, scholarships or group-specific tuition rates.
- Previous Chamberlain University students are ineligible.

Continuing Eligibility

• Maintain a minimum enrollment of three credit hours per semester.

Grant Application Requirements

• Signed Become Extraordinary Grant Terms and Conditions Eligibility Requirements form.

IMPORTANT NOTE: All grants and scholarships are limited based on availability of funding. Chamberlain University reserves the right to change offerings at any time. These are one-time awards that students may receive once within their life cycle.





BRIGHT FUTURES GRANT

The Bright Futures Grant is for students looking to further their education in select Nursing programs at Chamberlain University.

Grant Amount: \$400 per session for up to five sessions (up to \$2,000) for MSN Clinical Tracks.

Initial Eligibility

- Acceptance and commitment to a Master of Science in Nursing (MSN) Clinical Track Program at Chamberlain University.
 - Nurse Practitioner Certificate programs are also eligible for this grant.
- Must be a student who originally applied to Chamberlain but was unable to start.
- Maintain a minimum enrollment of three credit hours in the first session.
- Continuing students are ineligible.

Continuing Eligibility

• Must maintain session-to-session continuous enrollment of at least three credit hours per session for five consecutive sessions.

Grant Application Requirements



BRIGHT PROSPECTS GRANT

The Bright Prospects Grant is for students looking to further their education in select Nursing programs at Chamberlain University.

Grant Amount: \$150 per session for up to five sessions (up to \$750 for Non-Clinical Tracks and Accelerated MSN.

Initial Eligibility

- Acceptance and commitment to one of the following Chamberlain programs:
 - Master of Science in Nursing (MSN) Non-Clinical Tracks.
 - Accelerated Master of Science in Nursing (MSN) Option.
- Must be a student who originally applied to Chamberlain but was unable to start.
- Maintain a minimum enrollment of three credit hours in the first session.
- Continuing students are ineligible.

Continuing Eligibility

• Must maintain session-to-session continuous enrollment of at least three credit hours per session for five consecutive sessions.

Grant Application Requirements





COMPLETE WITH PURPOSE GRANT

The Complete With Purpose Grant encourages students in select programs who have sat out three or more sessions and are close to graduating to complete their degree.

Grant Amount: \$150 per session for 6 consecutive sessions (up to \$900).

Initial Eligibility


- Must enroll in one of the following degree programs at Chamberlain University:
 - $\circ\,$ RN to BSN Degree Completion Option (including RN-BSN to MSN)
 - Master of Science in Nursing (MSN) (Non-Clinical Tracks Only)
 - Master of Public Health (MPH) degree program
 - Master of Social Work (MSW) degree program
- Must not have attended classes over the last three sessions and are now enrolling in an eligible session in one of the above programs.
- Readmit students are not eligible.
- Student must have 18 credit hours or less remaining in their degree program.
- Accelerated programs (such as Accelerated RN-MSN and Accelerated MSN) are not eligible for this grant.

Continuing Eligibility

- Must maintain continuous enrollment for six consecutive sessions to receive the full amount of the award.
- Must be in good standing and maintain good academic standing for continued grant eligibility.

DAISY HONOREE & EXPANDED DAISY SCHOLARSHIP

A scholarship for Registered Nurses who have won The DAISY Award, The DAISY Team Award, The DAISY Nurse Leader Award, DAISY Award for Extraordinary Nursing Students, DAISY Award for Extraordinary Nursing Faculty, DAISY Lifetime Achievement Award, or the DAISY Nursing Ethics Award through The DAISY Foundation.

Grant Amount: \$15% tuition savings or 5% savings on tuition if applied in conjunction with an IEP tuition reduction, alumni discount, military benefit or post-licensure graduate grant/scholarship for a total tuition savings of up to 35%.

Initial Eligibility

- Must be a recipient of The DAISY Award from The DAISY Foundation through their employer or school.
 - Must provide a copy of The DAISY Award Certificate or verification from The DAISY Foundation.
- Enrollment in a Chamberlain University post-licensure degree program or Nurse Practitioner Certificate program.

Continuing Eligibility

- Students will continue to receive the eligible percentage for every session of enrollment.
- If students elect to utilize other eligible group-specific tuition rates, internal grants, or internal scholarships after starting the program, the student's eligibility will be reevaluated. Students will be awarded the most financially beneficial award(s) for them.

Grant Application Requirements



EXPANDED NURSING EXCELLENCE GRANT

The Expanded Nursing Excellence Grant is an expansion to the Nursing Excellence grant for DNP students who are receiving a select group-specific tuition rate.

Grant Amount: Waives \$320 per session for the first two sessions (up to \$640).

Initial Eligibility

- Acceptance and enrollment in Chamberlain University's DNP degree program.
- Must be eligible for one of the following group-specific tuition rates: Healthcare Education Partnership, Military or Alumni.
- Must enroll in three credit hours in the first session.
- Continuing students are ineligible.

Continuing Eligibility

- Maintain good academic standing.
- Must enroll in five credits per session to qualify for full grant funding.

Grant Application Requirements

• Chamberlain will review admission application materials and award the grant to all eligible students.

The Extraordinary Nurses Grant will provide tuition savings for students applying to select Nurse Practitioner certificate and degree programs.

Grant Amount: Up to 10% savings on tuition.

Initial Eligibility

- Acceptance and commitment to one of Chamberlain University's Nurse Practitioner degrees or certificate programs.
- Minimum enrollment of three credit hours in the first session.
- Continuing students are ineligible.
- Applicants must be new or readmit students.

Continuing Eligibility

• Must maintain minimum continuous enrollment of three credit hours per semester.

GREAT PROMISE GRANT

The Great Promise Grant is for students looking to further their education in select Nursing programs at Chamberlain University.

Grant Amount: \$100 per session for up to five sessions (up to \$500) for RN to BSN or RN-BSN to MSN Programs.

Initial Eligibility

- Acceptance and commitment to one of the following Chamberlain University programs:
 - RN to BSN Degree Completion option.
 - RN-BSN to MSN Online option.
- Must be a student who originally applied to Chamberlain but was unable to start.
- Minimum enrollment of three credit hours in the first session.
- Continuing students are ineligible.

Continuing Eligibility

• Must maintain a minimum continuous session-to-session enrollment of at least three credit hours per session for five consecutive sessions.

Grant Application Requirements



DNP

HBCU LEADERSHIP GRANT

Through this grant, Chamberlain University encourages eligible Historically Black Colleges and Universities (HBCU) employees to enroll in Chamberlain University's Doctor of Nursing Practice (DNP) degree program.

Grant Amount: Up to 100% of tuition, student service charges and course resource fees for four consecutive sessions (up to \$12,532).

Initial Eligibility

- Acceptance into Chamberlain University DNP degree program.
- Employed with an HBCU institution as identified by the U.S. Department of Education.
- New or readmit students are eligible.

Continuing Eligibility

• Must maintain a minimum continuous enrollment of three credit hours per session for four consecutive sessions to receive the maximum value of the grant.

Grant Application Requirements

- Completed Healthcare/Education Partnership Eligibility form.
- Signed HBCU Leadership Grant Terms and Conditions Eligibility Requirements form.

IMPORTANT NOTE: All grants and scholarships are limited based on availability of funding. Chamberlain University reserves the right to change offerings at any time. These are one-time awards that students may receive once within their life cycle.

MSN CURRICULUM ADVANTAGE GRANT

The MSN Curriculum Advantage Grant was created to help eligible readmit students cover the cost of the additional required coursework due to the changes in the MSN curriculum.

Grant Amount: 50% of tuition and APRN fee (if applicable) for up to two consecutive sessions for students who qualify for one course, and up to four consecutive sessions for students who qualify for two courses.

Initial Eligibility

- Must be a previously enrolled student who has sat out six or more consecutive sessions.
- Non-Matriculating students are ineligible.
- Must have previously passed and completed NR-501/NR-501NP and/or NR-506.
- Student must be enrolled in one of the following MSN degree or certificate programs:
 - MSN-Nurse Practitioner Degree Track programs (Family Nurse Practitioner, Adult Gerontology Acute Care, Adult Gerontology Primary Card, Psychiatric-Mental Health).
 - MSN Non-Clinical Degree Programs (Healthcare Policy, Nurse Educator, Nurse Executive, Nurse Informatics, Population Health).
 - Nurse Practitioner Graduate Certificate (AGACNP, AGPCNP, FNP, and PMHNP).
 - Non Clinical Graduate Certificates (HealthCare Policy, Nursing Education, Nursing Informatics, Nursing Leadership, Population Health, and Leadership Foundations).

Continuing Eligibility

- Must remain in good academic standing.
- Must enroll in three credit hours each session for two consecutive sessions if the grant is offered to cover one course and four consecutive sessions if the grant is offered to cover two courses.

NEW STUDENT CALIFORNIA TUITION SAVINGS OFFERING

Chamberlain University is offering tuition savings for eligible California nurses interested in our RN-BSN Degree Completion option.

Grant Amount: 17% tuition savings (up to \$4,858) or 25% tuition savings (up to \$7,144) if eligible to participate in a Healthcare Education Partnership.

Initial Eligibility

- Enrollment in a Chamberlain University RN to BSN Online Degree Completion Option or RN-BSN to MSN option (*undergraduate coursework only*).
- Must be a new or readmit student.
- Must have an address and be a nurse in the State of California.

Continuing Eligibility

- May not sit out more than six consecutive sessions.
 - Sitting out more than six consecutive sessions will require readmission and tuition savings may no longer be available.
- Students receiving the RN to BSN Savings Offering may lose this benefit in the event Chamberlain lowers its standard tuition rate below \$527.05 per credit hour (\$476.25 per credit hour for eligible Institutional Education Partner students). If the tuition rate is lowered below this threshold, students will be charged at the more beneficial tuition rate.

NEW STUDENT TUITION SAVINGS OFFERING

Chamberlain University is offering tuition savings for eligible applicants interested in our RN-BSN Degree Completion option.

Grant Amount: 17% savings on tuition (up to \$4,858) or 25% savings on tuition (up to \$7,144) if eligible to participate in a Healthcare Education Partnership.

Initial Eligibility

- Acceptance into a Chamberlain University RN to BSN Online Degree Completion Option or RN-BSN to MSN Option (*undergraduate coursework only*).
- Must have an address and be a nurse in an eligible state.
 May not reside in California, Georgia, Massachusetts, Maine, Montana or North Dakota.

Continuing Eligibility

- May not sit out more than six consecutive sessions. Sitting out more than six consecutive sessions will require reapplication to Chamberlain and tuition savings may no longer be available.

NR 565 SUPPORT GRANT

The NR 565 Support Grant was created to help eligible currently enrolled students cover the cost of NR 565 due a change in the Nurse Practitioner Graduate Certificate Curriculum

Grant Amount: 100% of tuition and fees for NR-565.

Initial Eligibility

- Must be currently enrolled in the Nurse Practitioner Graduate Certificate (Adult Gerontology Acute Care and Psychiatric-Mental Health tracks only) program with a start session of January 2024 or prior.
 - Family Nurse Practitioner and Adult Gerontology Primary Care track concentrations are not eligible.
- Must be a continuing or resume student who is enrolled for the March 2024 session forward and has a requirement to take NR 565 in Degree Works.
- New and readmit students are ineligible.
- Must be in good academic standing.

Continuing Eligibility

- Must be enrolled in NR-565 for the grant to disburse.
- Must remain in matriculating status.
- Must remain in current concentration of study. If the student changes concentration in March 2024 or later, they would become ineligible.

Grant Application Requirements

• Chamberlain will award the grant to eligible students when the student is enrolled in NR-565.



NEXT STEP GRANT

The Next Step Grant is for new or readmitted students looking to fulfill a Nurse Executive role by completing a degree or certificate in Chamberlain University's MSN Executive Track.

Grant Amount: \$300 per session (up to \$3,600).

Initial Eligibility

- Application and commitment to either an MSN Executive Track Degree or an MSN Executive Track Certificate.
- Must be a new or readmit student.
- Must enroll in three credit hours in the first session.
- Continuing students are ineligible.

Grant Application Requirements

• Chamberlain will review admission application materials and award the grant to all eligible students.

NP ALUMNI GRANT

The NP Alumni Grant is for NP Certificate students who need to make up coursework due to sitting out of classes for over five years.

Grant Amount: 50% savings on tuition and APRN fees up to the capped amount.*

Initial Eligibility

- Acceptance and enrollment into any one of Chamberlain University's Nurse Practitioner certificates (AGACNP, AGPCNP, FNP, or PMHNP).
- Must have completed NR-586: Population Health & Epidemiology for Advanced Nursing Practice, NR-507:Advanced Pathophysiology, and/or NR-509: Advanced Physical Assessment five years prior to retaking the courses (ex: November 2018 for January 2024 start, January 2019 for March 2024).
- Must enroll in three credit hours in the first session.
- Must have earned a Master of Science in Nursing Family Nurse Practitioner from Chamberlain.
- Continuing students are ineligible.

Awarding Information

- Students awarded this grant will be charged at the Alumni Tuition Rate and have an additional 50% savings on tuition and APRN fees applied each session up to the capped amount.
- *Capped amounts are based on how many courses a student must make up due to sitting out for over five years:
 - 1 course: Capped at \$2,580.
 - 2 courses: Capped at \$5,160.
 - 3 courses: Capped at \$7,740.

Continuing Eligibility

- Must maintain a minimum enrollment of at least three credit hours per session.
- Must maintain a cumulative grade point average (CGPA) of at least 2.0 on a 4.0 scale and remain in good academic standing.

• Signed NP Alumni Grant Terms and Conditions Eligibility Requirements form.



NURSING EXCELLENCE GRANT

The Nursing Excellence Grant is for new students who are prepared to begin Doctorate-level coursework at Chamberlain University.

Grant Amount: Covers \$320 of the Student Services Fee per session (up to \$3,840).

Initial Eligibility

- Acceptance and enrollment in Chamberlain's DNP degree program.
- Applicants must not have previously attended Chamberlain.
- Must enroll in three credit hours in the first session.

PUBLIC HEALTH COMMUNITY GRANT

The Public Health Community Grant is for students pursuing a career in a public health-related field.

Grant Amount: 25% tuition savings (up to \$6,342) tuition savings.

Initial Eligibility

- Must hold a Bachelor's degree in any field.
- Enrollment in a Public Health degree-seeking program at Chamberlain University.
- Enroll in a minimum of three credit hours for your first session.
- Must start the session as a new or readmit student.
- Continuing and non-matriculating students are not eligible.
- This grant cannot be utilized with any other partnership benefit or specialized tuition rate.

Continuing Eligibility

- Must remain enrolled in Public Health degree-seeking coursework at Chamberlain.
- Must remain in good academic standing.

Grant Application Requirements

• Signed Public Health Community Grant Terms and Conditions form.



SOCIAL IMPACT GRANT

The Social Impact Grant is for students pursuing a career in a social work-related field.

Grant Amount: 20% tuition savings (up to \$8,340) on Master of Social Work (MSW) coursework at Chamberlain University for the duration of enrollment.

Initial Eligibility

- Must enroll in Social Work coursework at Chamberlain.
- Must have a Bachelor's degree in any field.
- Must have a minimum 2.5 CGPA on a 4.0 scale for the MSW Traditional option or a 3.0 CGPA on a 4.0 scale for the MSW Advanced Standing option.
- Continuing students are ineligible.
